The **NEW** Prescribed Waste Regulation (Environment Protection (Industrial Waste Resource) Regulation 2009) will be fully in force from 1 July 2009. This Regulation will provide a framework on how hazardous waste must be managed in Victoria. The Regulation details the obligations of waste generators, transporters, treaters and recyclers, and will set out the **NEW** process and method for hazardous waste disposal.

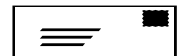
