





### **Climate Solutions Fund - Emissions Reduction Fund (ERF)**

https://www.industry.gov.au/funding-and-incentives/emissions-reduction-fund

- \$2 billion top up to Emissions Reduction Fund
- New projects that reduce GHG emissions through activities that store carbon or avoid emissions
- Through projects involving new technology, upgrading equipment, changing business practices
- Areas: vegetation management, soil carbon, agriculture, energy consumption, waste, transport, coal and gas
- Must be conducted in accordance with an approved methodology (36 methods)
- Create Australian Carbon Credit Units (ACCUs)
- 1 ACCU equals 1 tonne of CO<sub>2</sub> equivalent stored or avoided by a project, average ACCU price across all 8 auctions: \$12.02, ninth auction averaged \$14.17
- Contract with the Clean Energy Regulator
- Revenue stream for generating ACCUs
- Applications recently closed. Open: 12 April 2021 for next project registration for ERF auction







## **Climate Solutions Fund – The Climate Solutions Package**

- \$3.5 billion additional investment for The Climate Solutions Package to deliver existing climate change mitigation programs
- The Climate Solutions Package:
  - \$2 billion top up to Emissions Reduction Fund
  - Support for new energy efficiency measures for homes, businesses and community organisations
  - Development of a national strategy for electric vehicles
  - Further investment and support for pumped hydro projects
- Applications <u>ongoing</u>







### **National Landcare Program**

- Currently in Phase 2, \$1 billion investment from July 2018 to June 2023
- Most funding programs under NLP now closed, except:

- Ongoing funding of \$5.3 million annually

  - Farm investment loans
    - Improve the strength, resilience and profitability of farm businesses
  - Drought loans
    - Prepare for, manage through or recover from drought
  - AgriStarter Loan
    - Assist first time farmers and loans to support farm succession arrangements







### **Manufacturing Modernisation Fund**

- It provides co-funded grants to transform manufacturing and to support job growth and a more highly skilled workforce.
- \$50 million will be available for this grant opportunity from 2020-21 to 2022-23
- Co-funding grants of between \$100,000 and \$1 million, up to 25 per cent of eligible project expenditure.
- For Small to medium manufacturing enterprises (SMEs) with up to 199 employees
- Applications closed. <u>Check website for future opening.</u>







## **Cooperative Research Centres Projects (CRC-P) Grants**

- Department of Industry, Innovation & Science
- Projects that develop a new technology, product or service
- Also open to other sectors
- Short term (up to 3 years) matched funding for industry-led collaborations\*
- Matched funding between \$100,000 to \$3 million
- Applications close: <u>25 March 2021</u>

\*Collaborations must include at least two Australian industry organisations, including one SME and one research organisation







### **Boosting Australia's Diesel Storage Program**

- Program will run over 3 years to 2023-2024.
- \$200 million in competitive grants
- Aim to support the construction of an additional 780 megalitres of diesel storage in Australia
- Eligible Projects
  - Minimum grant amount is \$6 million up to \$33.3 million available for successful projects, co-contribution required
  - The Government will cover up to 50% of eligible project costs with industry matching the funding
  - Expected to start construction in mid-2021 and be completed by 30 June 2024
- Applications closed (22 Feb 2021). Check website for future opening.







### **R&D Tax Incentive**

- Department of Industry, Innovation & Science
- Tax offsets of 43.5% (refundable) or 38.5% for costs incurred on eligible R&D activities depending on company's annual aggregated turnover
  - Eligible R&D expenditure or notional deductions of at least \$20,000 (unless using a Research Service Provider or a Cooperative Research Centre)
- Applications ongoing, must be made within 10 months of the end of the income year







### **Product Stewardship for Oil Program**

- Businesses that recycle or use recycled oil
- Financial benefit of up to 50 cents per litre of oil
  - Rates vary depending on extent to which the oil is processed and end product of the recycling activity
- Supports and encourages environmentally-sustainable management of used oil
- Applications open







# Regional and Remote Communities Reliability Fund

- The program will provide up to \$50.4 million over 5 years and will run until 2023-24
- Focus on feasibility studies for microgrid technologies to replace, upgrade or supplement existing electricity supply arrangements

## **Grid Reliability Fund**

- \$1 billion fund administered by CEFC
- Eligible investments:
  - Energy storage projects (e.g. hydro, batteries)
  - Transmission and distribution infrastructure
  - Grid stabilising technologies
- Government is currently reaching agreements with individual project proponents
  - Applications closed, unclear if there will be future rounds. Check website for future opening.







### **Hotel Energy Uplift Program**

- The program provides grants to support hotels to reduce their energy use, improve energy productivity and deliver carbon abatement.
- From \$10,000 to \$25,000
- \$10.2 million available for this grant opportunity
- For small to medium sized hotel, motel or serviced apartment complex with 1 to 99 guestrooms.
- Applications close: 1 April 2021







## National Environmental Science Programme - Research

- Funding for environment and climate research
- 1<sup>st</sup> phase: \$145 million over 2015 to 2021 delivered through 6 research hubs
  - Clean Air and Urban Landscapes Hub
  - Marine Biodiversity Hub
  - Threatened Species Recovery Hub
  - Earth Systems and Climate Change Hub
  - Northern Australia Environmental Resources Hub
  - Tropical Water Quality Hub
- 2<sup>nd</sup> phase will invest \$149 million (2020-21 to 2026-27) 4 new research hubs
- Applications ongoing







## **National Indigenous Australians Agency**

- Aims to support responses that address local needs and benefit Indigenous Australians, delivering outcomes aligned to community and government priorities
- Grants up to \$100,000
- Eligibility
  - Only organisations directly approached by the Agency
  - Small scale and short-term (1 year), one-off proposal
  - Proposals to address immediate needs and local issues.
  - Applications close: <u>17 May 2022</u>







# The Improved Access to Agricultural and Veterinary Chemicals initiative

- Grants from \$5,000 to \$1,000,000 for wildlife sanctuaries and conservation of endangered species
- Aim to support wildlife rehabilitators to rescue, treat and rehabilitate wildlife impacted by bushfires returning them into natural environments
- Eligibility:
  - Wildlife carer organization identified in the application guidelines.
  - Have an Australian Business Number (ABN), and an Australian financial institution account
  - Be invited to apply for a grant.
  - Applications close: 30 June 2021













## **Victorian Energy Upgrades (VEU)**

- Energy-efficient products and services made available to homes and businesses at a discount by Accredited Providers
- Providers can generate Victorian Energy Efficiency Certificates (VEECs) based on greenhouse gas savings associated with Prescribed Activities they undertake
- Previous EREP participants (Scheduled Activity Premises) can opt-in to generate certificates
- DELWP exploring the introduction of new activities to the program such as refrigerated cold rooms

  - Stream 1: supports localised community projects
  - Stream 2: supports large scale initiatives that are delivered to communities all across Victoria
- From \$25,000 to \$250,000. Co-contribution expected: \$1; \$5
- For community groups, social enterprise, charities, not-for-profit organisations






# **Energy Savings Scheme (ESS)**


