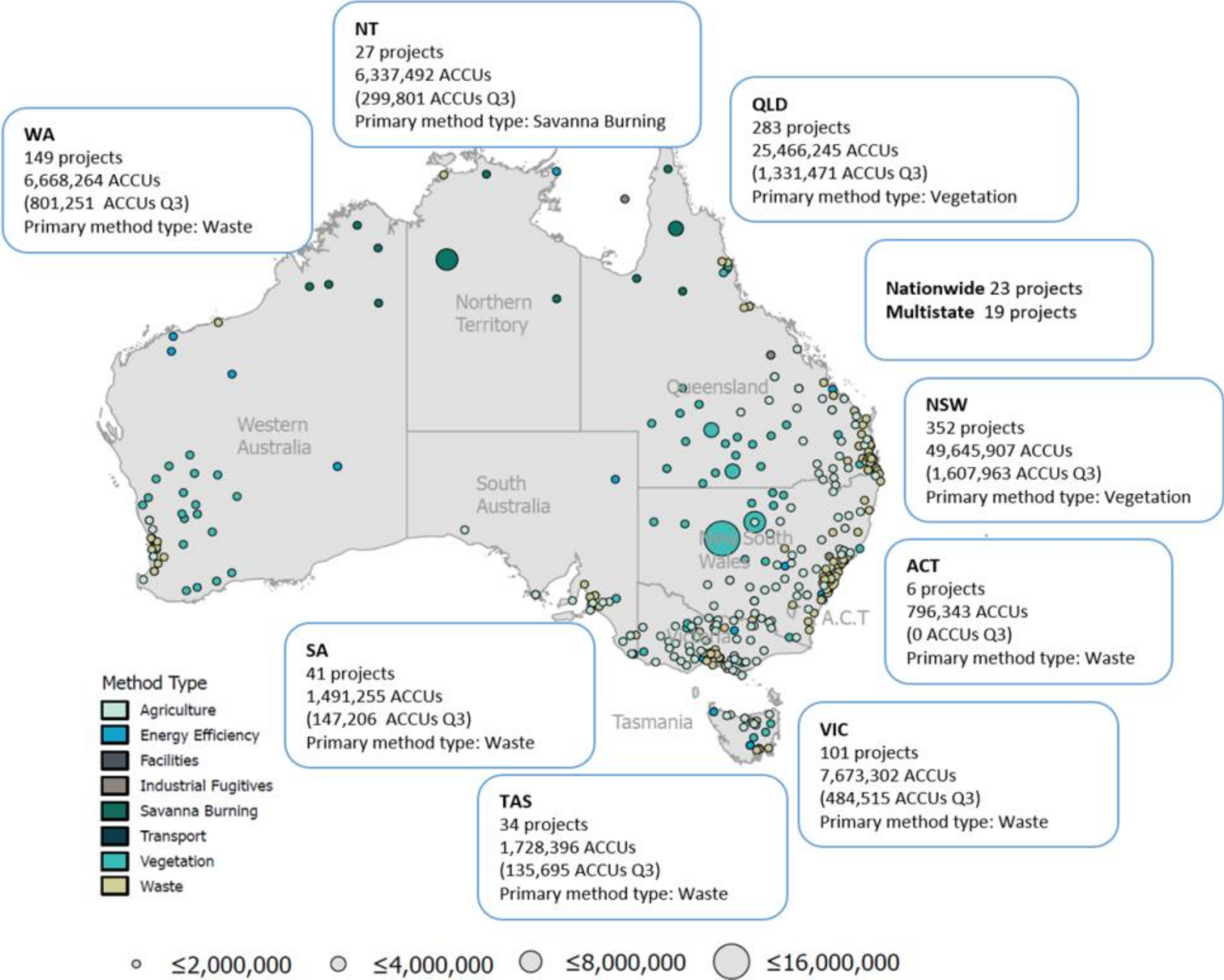


Climate Solutions Fund - Emissions Reduction Fund (ERF)



- Projects that reduce GHG emissions through activities that store carbon or avoid emissions
- Through projects involving new technology, upgrading equipment, changing business practices
 - Areas: vegetation management, soil carbon, agriculture, energy consumption, waste, transport, coal and gas
- Must be conducted in accordance with an approved methodology: land-based / industrial
- Create Australian Carbon Credit Units (ACCUs)
- 1 ACCU equals 1 tonne of CO2 equivalent stored or avoided by a project, 13th auction averaged \$16.94 per ACCU
- Contract with the Clean Energy Regulator
- Revenue stream for generating ACCUs
- ERF auctions regularly

Climate Solutions Fund – The Climate Solutions Package



- \$3.5 billion additional investment for The Climate Solutions Package to deliver existing climate change mitigation programs
- The Climate Solutions Package:
 - \$2 billion top up to Emissions Reduction Fund
 - Support for new energy efficiency measures for homes, businesses and community organisations
 - Development of a national strategy for electric vehicles
 - Further investment and support for pumped hydro projects
- Applications ongoing

Advancing Renewables Program

- For businesses undertaking renewable energy projects

- Activities must either involve a renewable energy technology or involve methods (including desktop studies and analysis) that can contribute to the program outcomes.

Energy Efficiency Communities Program

Food & Beverage Manufacturing Grant for SMEs

- Small and medium food and beverage manufacturing businesses (<200 employees) eligible
- Energy efficiency upgrades, energy audits, energy metering, etc
- Up to 100% of costs eligible for between \$10,000-\$25,000
- Applications open until 3 March (tomorrow)

- Access free personalised energy consultation and access to a Small Business Energy Check tool

- Financial benefits for businesses that recycle oil
- Aims to support and encourage the environmentally sustainable management of used oil. Levy used to provide benefits to recyclers of used oil and users of gazetted oils.

Victorian Energy Upgrades (VEU)



- Incorporates previous Victorian Energy Efficiency Target (VEET) scheme
- Energy-efficient products and services made available to homes and businesses at a discount by Accredited Providers
- Providers can generate Victorian Energy Efficiency Certificates (VEECs) based on greenhouse gas savings associated with Prescribed Activities they undertake
- Previous EREP participants (Scheduled Activity Premises) can opt-in to generate certificates
- DELWP exploring the introduction of new activities to the program such as refrigerated cold rooms
- Applications ongoing

Regional Jobs Fund



- Facilitate job creation, retain existing jobs, attract and facilitate investment
- Focus on regional competitive advantage or high-growth potential businesses
- Diversify regional employment base
- Support for projects and infrastructure through 5 public grant streams: Investment Attraction; Innovation and Productivity; Employment Precincts; Market Access and Skills Development
- Applicants expected to make financial contribution or third-party funding
- Up to \$5 million funding

- Assist Victorian Communities to transition to a circular economy
- Applicants must contribute \$1 for every \$5 requested, including in-kind contributions
- Eligible organisations include a registered charity; a community group engaged in charitable or other community-based activity; a social enterprise or other not-for-profit organisation.

Stream 1: Local Community projects

- Funding between \$25,000 and \$59,000

Stream 2: Regional Community projects

- Funding between \$60,000 and \$250,000
- Applications close 31 March 2022

Recycling Victoria Councils Fund Round 2



- Supports Victorian Councils in reducing the amount of waste going to landfill or increasing the volume of materials reused, repaired, repurposed or recycled.
- Available to local governments
- Funding from \$80,000 to \$500,000 available, co-contribution 1:1 (large councils) or 2:1 (small councils)
- Applications open, close 14 April 2022

Small Business Energy Saver Program



- Eligible for Victorian small businesses that have 1 to 19 FTE employees
- This program assists small businesses to implement upgrades which will lower their operational costs.
- The equipment upgrades eligible for the bonus, include heat pump hot water systems, space heating and cooling systems, water-efficient pre-rinse spray valves, low-flow shower heads, refrigerators and upright freezers, refrigerated display cabinets, fan motors in refrigeration systems
- Bonuses of up to \$2000

Solar for Business



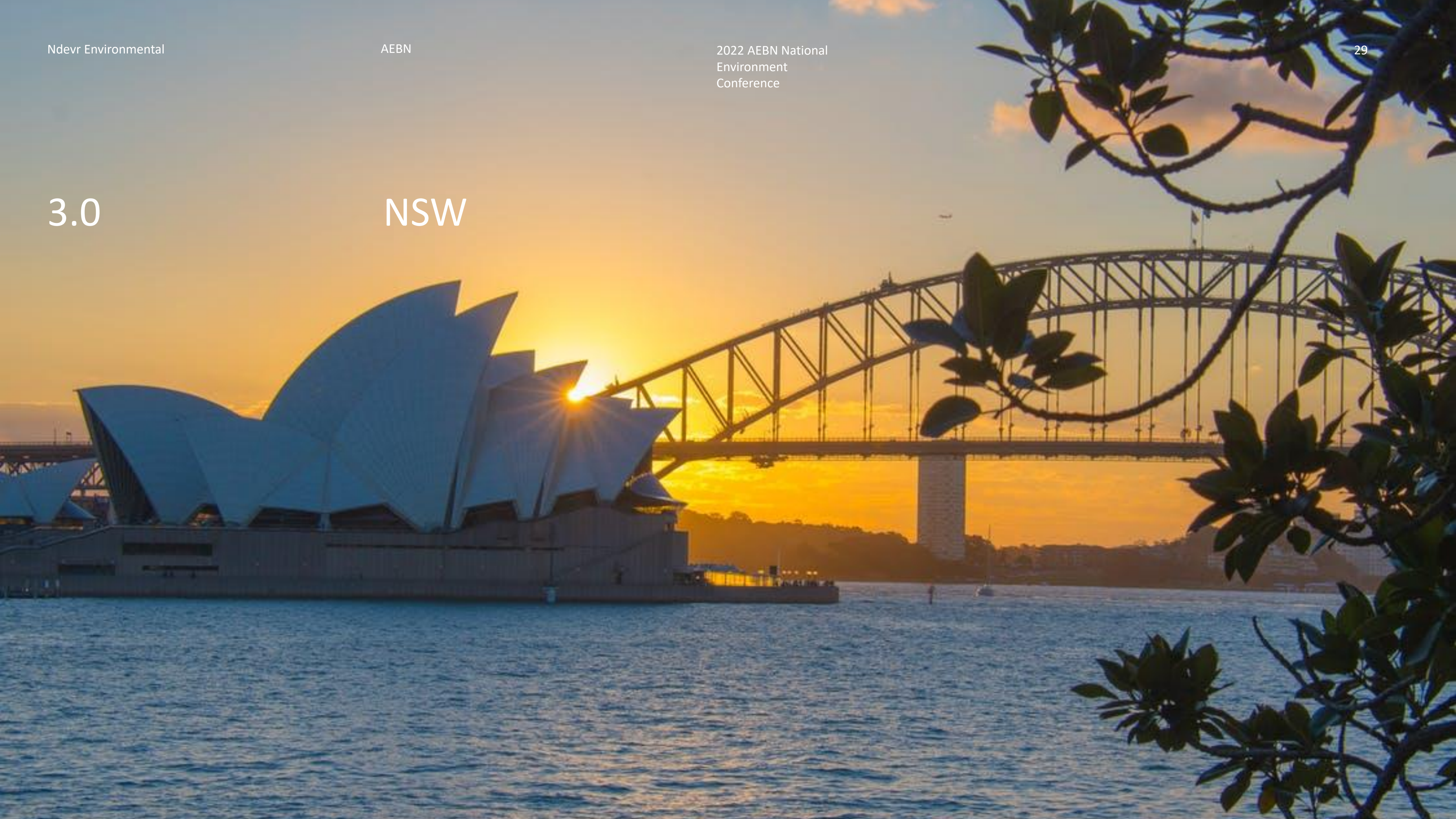
- Rebates for Victorian small businesses to install a rooftop solar system
- Help small businesses reduce their energy costs by accessing the benefits of renewable energy.
- Eligible for businesses with less than 20 FTE
- Rebates up to 50% of net system cost to maximum value of \$3,500 until 20-21 all rebates allocated, reduced to \$1,750 thereafter
- Applications open

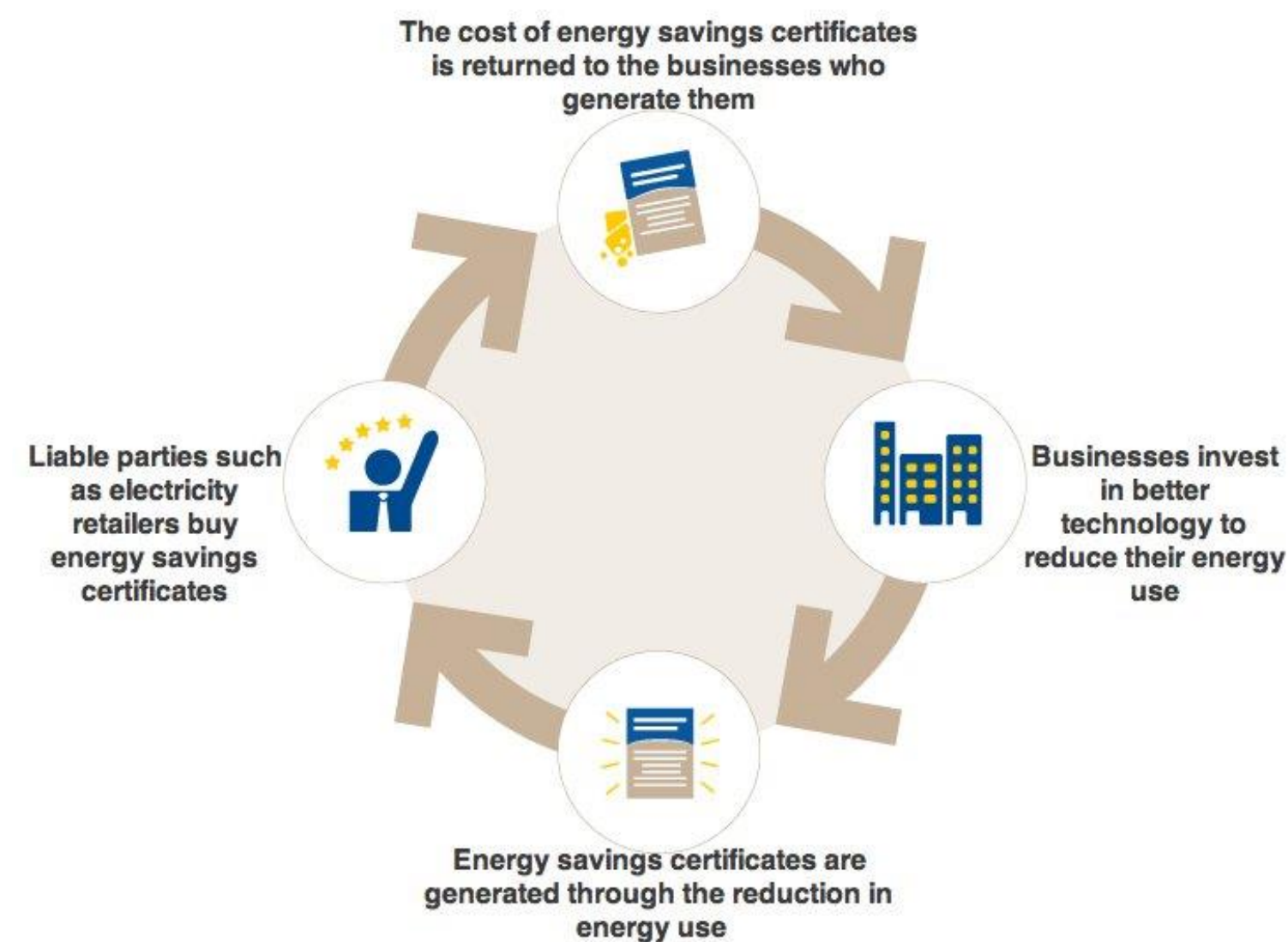

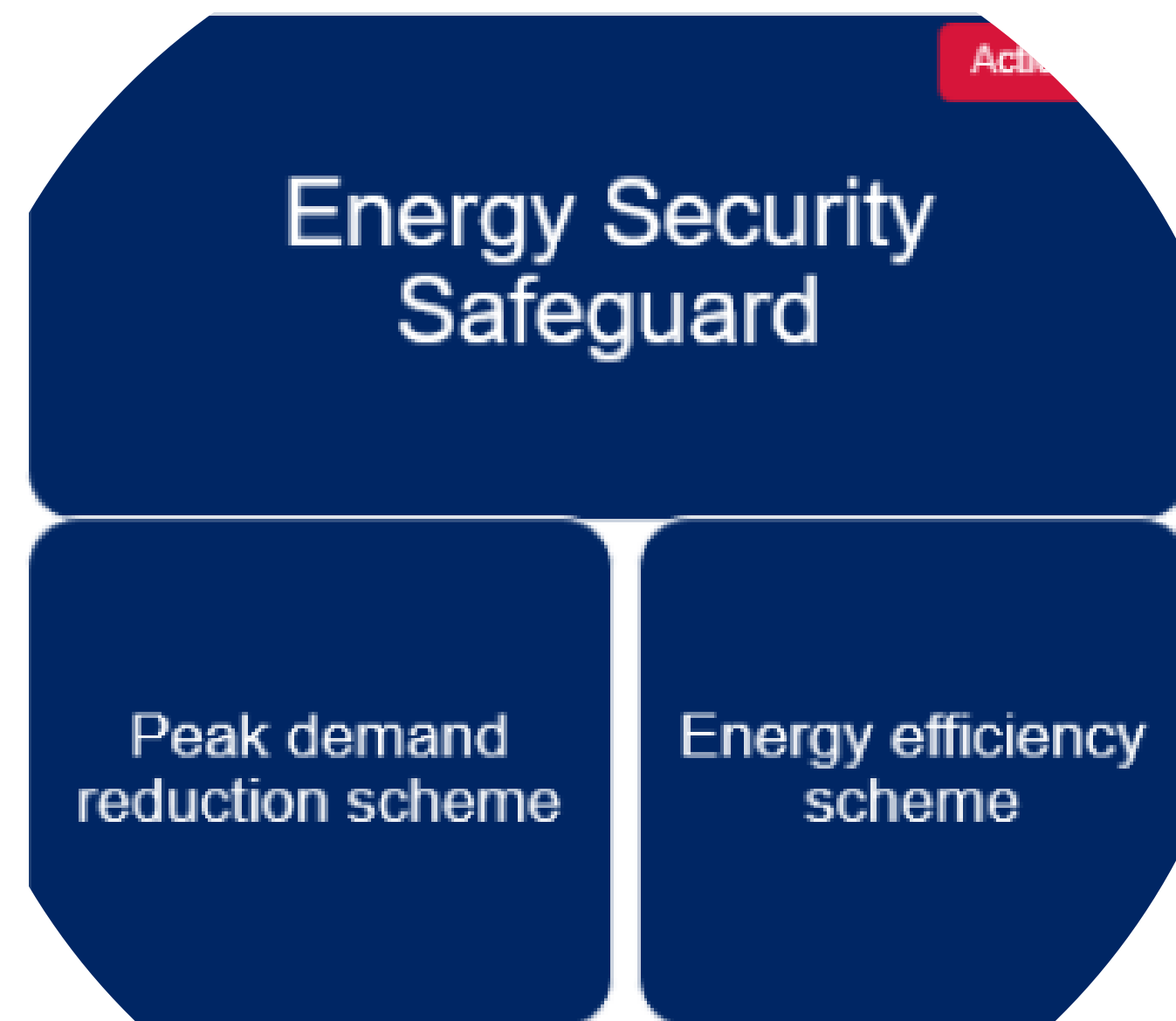
Energy Savings Scheme



- Financial incentives for organisations to invest in projects to install, improve or replace energy savings equipment
- Partner with or become an Accredited Certificate Provider (ACP) to undertake energy savings activities and generate energy savings certificates (ESCs)
- ESCs are created for every MWh of energy saved in each project
- Applications ongoing

Peak Demand Reduction Scheme



- Peak Demand Reduction Scheme to commence 2022-23 summer
- Financial incentives for organisations to reduce peak energy use by buying or installing equipment that uses less energy during peak times
- Partner with or become an Accredited Certificate Provider (ACP) to undertake energy savings activities and generate peak reduction certificates (PRCs)
- New activities to be announced as the scheme matures

Energy Saver Program



- Subsidised services, guides, training resources, tools and calculators to implement energy efficiency opportunities for businesses
- Various discounts and incentives
- Courses and webinars
 - Energy management courses
 - Equipment and technology courses
 - Webinars
- Applications ongoing

Bin Trim Rebate



- Reimbursements for SMEs to install small-scale recycling equipment & increase workplace recycling
 - Cardboard and plastic balers, expanded polystyrene compactors, shredders, source separation bins, etc.
- Eligibility: businesses with up to 400 FTE, and facility managers/small-scale recyclers handling waste from SMEs
- \$1,000 to \$50,000 (up to 50% capital cost)
- Free waste assessment to determine eligibility
- Applications open

Jobs Plus Program



- The \$250 million Jobs Plus Program will strengthen the NSW economy by creating new jobs
- The program will reduce the cost of establishment, financial risk and increase speed to market for businesses looking to scale and grow in NSW.
- Proponents seeking assistance through the Program will be eligible for a variety of support levers based on the number of jobs created.
- Eligibility:
 - For private and non-government sectors seeking to invest in job-creating projects, proposals and partnerships
 - Proponents will be eligible for a variety of support levers based on the number of jobs created.
- Applications close: 30 June 2022

Building Upgrade Finance



- Loans for environmental upgrades to commercial businesses in participating NSW local government areas.
- For owners or managers of commercial buildings.
- Applicants must own an existing non-residential building located within a participating council-external site area, or have the approval to upgrade the building (the building owner must sign the loan contract) and be upgrading a non-strata commercial building.
- Eligible works under Building Upgrade Finance are those that improve the energy, water or environmental efficiency or sustainability of a building.
- Loan amounts vary on a case-by-case basis

Remanufacture NSW



- Provides co-funding for waste and recycling infrastructure to support industry to respond to Australia's waste export ban.
- Targets waste materials subject to export ban: plastic, paper, cardboard, tyres

Stream 1: Infrastructure Projects

- Aims to establish new recycling infrastructure and equipment
- Co-funding from \$100,000 to \$300,000

Stream 2: Trial Projects

- Aims to trail innovations to manage waste streams noted
- Co-funding from \$50,000 to \$1,000,000
- Applications open, closing 11 March 2022

Clean Technology Innovation Research

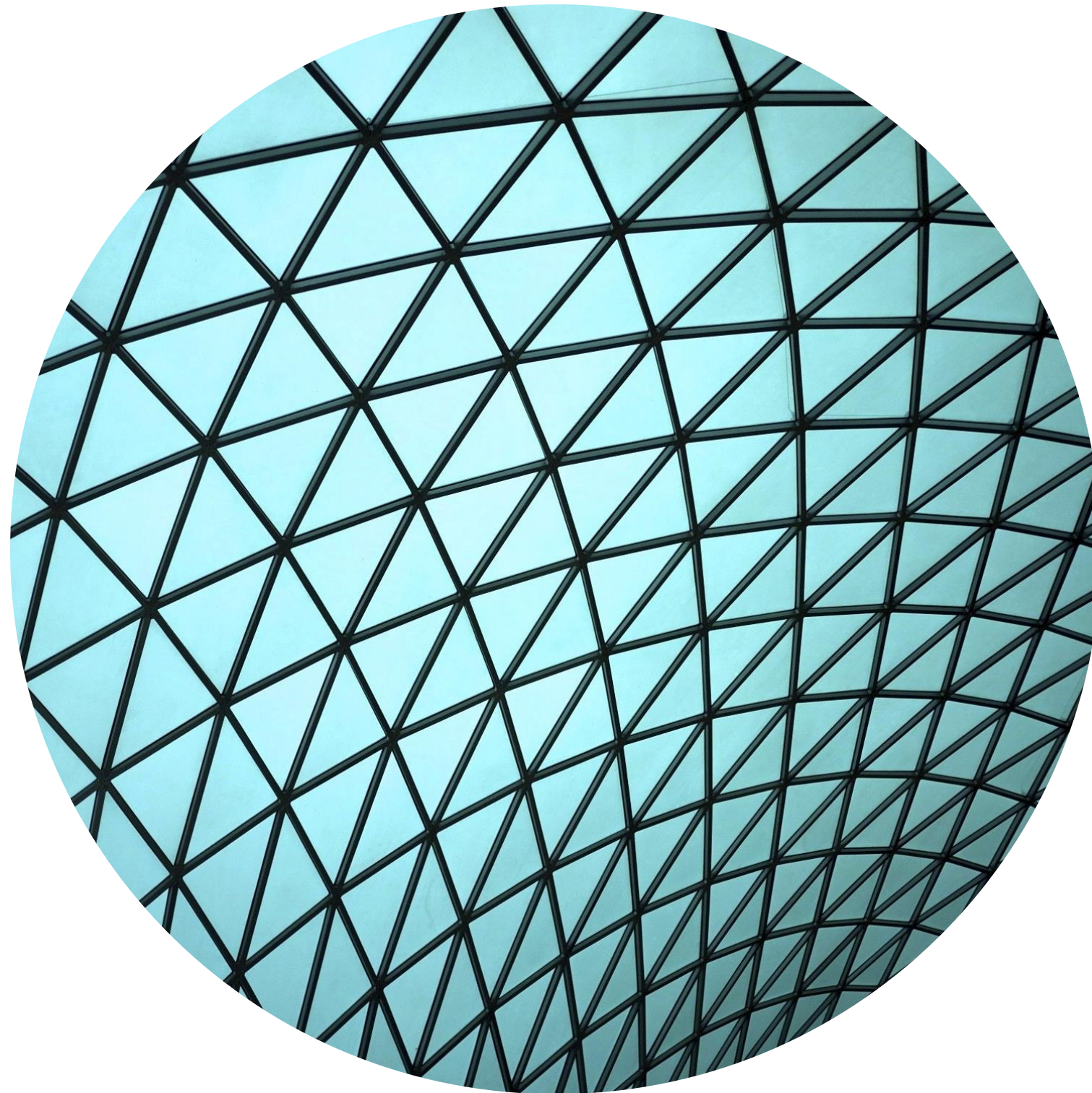


- Invests in research and development of commercially viable technologies, services or processes that have potential to significantly reduce emissions of high emitting or hard-to-abate sectors
- Program under NSW's Net Zero Industry and Innovation Program – Stage 1 of NSW Net Zero Plan for 2020-2030
- Requires Expression of Interest Application. Shortlisted applicants will progress to stage 2 to submit a full application
- Funding from \$400,000 to \$4m per project
- Grants awarded annually via 6 rounds, 2022 round TBC

Better Business Partnership



- Sustainability advice for businesses in Sydney's North Shore region, including the Ku-ring-gai, North Sydney and Willoughby City Council areas.

 - i. up to 50% of the cost for efficiency improvements - maximum of \$20,000

Lead Educate Assist Promote (LEAP) Grants



Funding to drive a more resource efficient and circular economy

- Aimed at coordinated business groups, peak industry bodies or associations
- Focus on circular economy and sustainability principles such as waste avoidance and reduction; materials efficiency; circular supply chains; design for reuse, repair, or remanufacture; extended producer responsibility/product stewardship
- Funding of \$100,000 per applicant (max. \$50,000 per fiscal year)

Assess Implement Monitor (AIM) Grant



- Subsidy for businesses wanting to improve their sustainability
- Up to 50% of eligible costs to total \$15,000
 - Up to \$10,000 for assessment (co-contribution 2:1)
 - Up to \$5000 (co-contribution 1:1) to implement assessment recommendations
- Eligible expenditure: Materials efficiency assessments, resource efficiency assessments (energy, water, waste), lean production assessments, sustainable procurement review / assessments, research, design and business case development for implementation of circular economy principles and energy audits or assessment

Incentives for Electric Vehicles SA



- Electric vehicle subsidy package for South Australian businesses and organisations
- For a vehicle to be eligible, it must be a new battery electric vehicle or hydrogen fuel cell electric vehicle registered for the first time on or after 28 October 2021 and valued below a price cap of \$68,750
- Available for 7,000 new battery electric and hydrogen fuel cell vehicles
- \$3,000 subsidy and 3-year registration fee exemption

 - supporting the development of the ACT as an export-oriented hub for renewable energy innovation
 - secure direct commercial benefits for ACT companies
- Three levels of funding up to \$30,000
- Applications open until funding exhausted
